INFORMATION UNDER ARTICLE 13 OF LEGISLATIVE DECREE - JUNE 30, 2003 - NUMBER. 196

Dear Customer

Under Article 13 of Legislative Decree 196/2003 laying down the "Code for the Protection of Personal Data", the writer, as owner of the treatment, informs you that the personal data acquired with reference to the relationships established will be processed in compliance with the aforementioned law.

Excluding transfers and communications made to comply with legal and contract obligations, the data supplied to the writer will be used only for legal obligations and may be shared for the sole purpose of protecting credit and better management of their rights to single commercial relationship, in particular:

- ✓ Banks for business information;
- ✓ Associations for consulting
- ✓ Consultants and service companies;
- ✓ Professionals for the fulfillment of tax and accounting obligations;
- ✓ Your personal data will not be in any case subject to disclosure;
- ✓ Personal data may be transferred to EU countries and non EU countries in respect of the purposes for which data are collected.

We remind that are granted you the rights under Art. 7 of Legislative Decree 30 June 2003 No. 196, and, in particular the right to access your personal information, ask for a correction, update and erasure, if incomplete, incorrect or collected in violation of the law, and to oppose their processing for legitimate reasons, addressing the request to the Owner of the Treatment.
